There was one documented requests for footage by MPD from program recipients that were successfully extracted. MPD detectives may also be in direct contact with a program recipient without that information being specifically tracked.

There were no arrests made in which video footage was extracted from a security camera owned by a program participant. MPD detectives may have viewed footage that was obtained directly from the program participants without that information being specifically tracked.

The program continues to be successful with no plans for future expansion. The program participated in a meeting with Logan Circle business owners to discuss how they can access the program.

*As of August 1, 2016 all PSAs are eligible to apply for rebates. Prior to August 1, 2016 rebate applications from PSAs 101, 102, 201, 203, 204, 205, 206,301, 304, 306, 401, 408, 601, 605, and 606 were ineligible. Until September 1, 2017, voucher applications from PSAs 101, 102, 201, 203, 204, 205, 206,301, 304, 306, 401, 408, 601, 605, 606 and 607 are ineligible.

In January 2019, MPD realigned PSA boundaries. The data in this report reflects the PSA at the time of application.
