There were four documented requests for footage by MPD from program recipients that were successfully extracted. MPD detectives may also be in direct contact with a program recipient without that information being specifically tracked.

There were three arrests made in which video footage was extracted from a security camera owned by a program participant. Two suspects were arrested in a Murder 1 case and 1 ADW. MPD detectives may have viewed footage that was obtained directly from the program participants without that information being specifically tracked.

The program continues to be successful with no plans for future expansion.

In January 2019, MPD realigned PSA boundaries. The data in this report reflects the PSA at the time of application.
